The Dutch UBO-register for corporate and other legal entities (the Netherlands)

Update 15 December: As of 27 September 2020, corporate and other legal entities that are incorporated or established under Dutch law and that are registered in the Dutch Trade Register are required to obtain, hold and register certain personal information on their ultimate beneficial owners (UBOs) in the Dutch UBO-register.

Basic Banking Service for everyone, undertakings now included! (Belgium)

In recent years, an increasing number of undertakings has been refused access to banking services or has seen its relationship with its longstanding bank terminated without receiving a statement of reasons. Although businesses have an obligation under Belgian law to open a current account with a bank or other financial institution, practice has shown that banks may be reluctant to open accounts. Many sectors have encountered difficulties, particularly the diamond sector, the hotel and catering industry, the gaming sector and "second-chance" entrepreneurship. This has left these undertakings unable to carry on their business, since they lack any effective legal means to force banks to accept them as clients. To read this update, *click here*

As announced in a previous article, the Belgian government wants to introduce a new tax in succession to the annulled tax on securities accounts. The final draft bill of this new tax has now been submitted to Belgian parliament.

Brexit: Luxembourg regulator clarifies actions to be taken in view of the end of the transitional period on 31 December 2020 (Luxembourg)

The CSSF issued a press release on 7 December 2020 on the management of Luxembourg AIFs by UK AIFMs and the marketing of UK UCITS and AIFs in Luxembourg. UK AIFMs or impacted funds must take certain actions by 31 December 2020 at the latest to the extent no action has been taken so far.

A 12-month grace period has been announced by the CSSF for the application of the European Single Electronic Format (ESEF) requirements in relation to annual financial reports. These requirements will therefore apply to the annual financial reports for periods beginning on or after 1 January 2021, rather than 1 January 2020.
